## **Vetting Criteria for "M" Mark Applications**

Events seeking "M" Mark status and funding support (if applicable) must meet the mandatory requirements stipulated in the Hong Kong "M" Mark Events Application Guidelines before they are being considered and assessed. For an exhibition match or tournament, the application has to meet the extra mandatory requirement on number of paid admissions<sup>1</sup>.

In addition to meeting the mandatory requirements, applications must attain a passing mark of 80 based on the following vetting criterion to be granted with the "M" Mark status and funding support (if applicable).

For an event held at a large football stadium (e.g. Hong Kong Stadium or Main Stadium of Kai Tak Sports Park), paid admission of at least 15 000 or 40% of the maximum capacity of the venue, whichever is higher) is required. For an event held at other venue, the accumulated paid admission is at least 8 000 per event. "Paid admission" means tickets in return of monetary payment. Complimentary tickets either as part of the sponsorship agreement or otherwise are not counted as "paid admission".

## Mechanism of Adjusting the Approved Funding Support

- (1) In the event that after the application has been approved, there are discrepancies / changes in the key parameters / deliverables of the events as compared with the proposals endorsed by Culture, Sports and Tourism Bureau and Major Sports Events Committee, such as players line-up / teams strength (including marquee players), attendance, impact on tourism, contribution to local economy, publicity impact, etc, and that such discrepancies / changes in the key parameters / deliverables will necessitate a reduction of score, the approved grants will be correspondingly adjusted based on the applicable funding ceiling of the final score.
- (2) In cases where the final score falls below the passing marks of 80, there will be a proportional reduction in the funding support and the Government reserves the right to revoke the "M" Mark status and funding support of the Event.

## Additional Key Performance Indicators for Exhibition Match or Tournament Evaluation

- (1) Two Key Performance Indicators will be used to evaluate and assess the final amount of funding to be released:
  - (i) the actual number of attendance / ticket sale; and
  - (ii) the eventual participation of all players / teams
- (2) For (i), if the ticket sale/attendance rate does not meet the minimum requirement, the total final grant by the Government will be deducted in accordance to the following proportion:

Attendance / Ticket Sale (base on no. of paid admission submitted by the applicant)	Total <u>FINAL</u> cash grant to be provided under M Mark System

>81% but short of minimum requirement	80% of total grant
Between 61% to 80% of minimum requirement	70% of total grant

(3) If the players line-up / teams strength deviates from the list endorsed by CSTB and there are no replacement fulfilling the vetting criteria, CSTB shall reserve the right to invoke the adjustment of grants.
